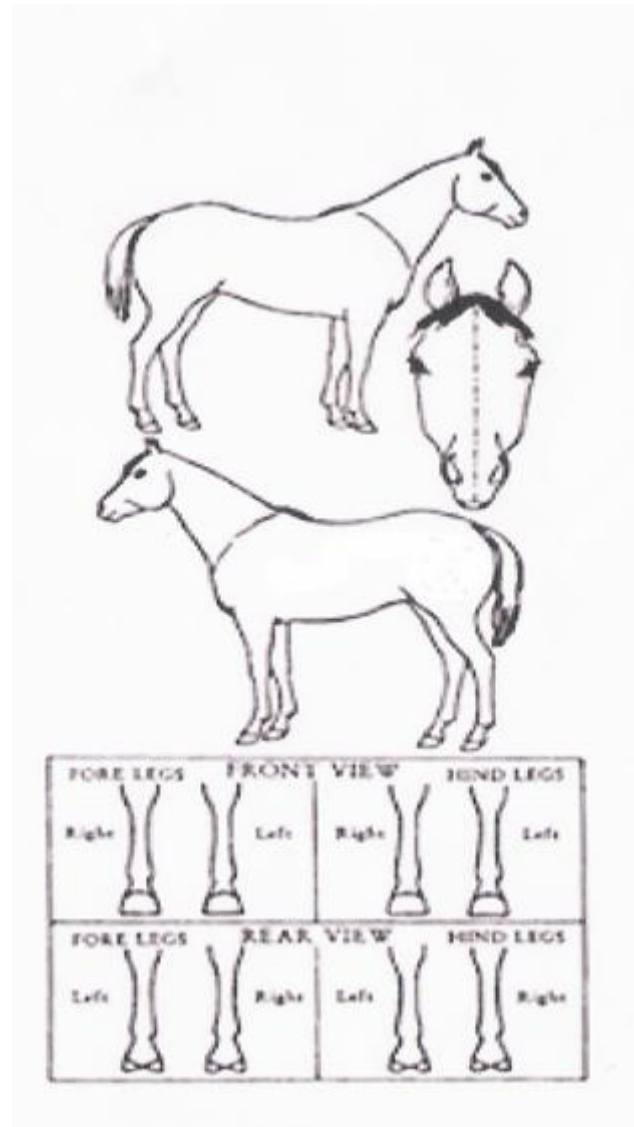

Please Note:

Any imported horse to be included in the HHANZ Stud book must be registered or eligible for registration in the Stud Book or Progeny registration of a member country affiliated with the World Haflinger Federation.

Application for registration must be accompanied by the original Registration Certificate which must show that the horse has been transferred into the name of the member making the application. The Executive may insist upon inspection of any horse before accepting the application for registration in the Association's Stud Book and may appoint an Inspector or Inspectors for that purpose and the expense of the inspection shall be borne by the applicant for registration.

Each imported horse may be inspected for the purpose of verification or identification by a Classifier appointed for that purpose by the Association.
